NEW JERSEY ECONOMIC DEVELOPMENT AUTHROITY Approved Legacy ERG Projects

Created by law in 2009, the intent of the Economic Redevelopment and Growth (ERG) program was to provide State incentive grants to developers to capture new State incremental taxes derived from a project's development to address financing gap. Applications to the ERG Program were evaluated to determine eligibility in accordance with N.J.S.A. 52:27D-489 a. through o. / N.J.A.C. 19:31-4, including having a redevelopment project that is located in a qualifying area; not having begun any construction at the site of the proposed project prior to submitting an application, except in certain cases; demonstrating an existing financing gap; meeting a 20% equity requirement; and, meeting a net benefit test. Grants are made annually based on the incremental eligible taxes actually generated as a result of the project.
